The Public Hearing (via videoconference) was called to order by Vice-Chair Reeve at 9:05 a.m. on July 11, 2007 at the Denver Lottery Office.

Vice-Chair Reeve began the Public Hearing with introductions from attendees in the Denver and Pueblo offices.

Vice-Chair Reeve next called for the items on the Public Hearing Agenda. He requested that Internet Coordinator Bev Saidel present the Rules.

Ms. Saidel reviewed Permanent Rule 6.UO, "Special" Cash Bingo, Game No. 390; Rule 6.UP, Mega Slots, Game No. 391; Rule 6.UQ, Colorado Millionaire, Game No. 392, Rule 6.UR, Deuces Wild, Game No. 393; Rule 6.US, Funky 5s, Game No. 394; Rule 6.UT, Lucky Numbers, Game No. 395. She described the features of the game, including the price point, the play style, the prize amounts, the number of times players may win on a ticket, the number of tickets, and the projected launch date for the games. Ms. Saidel stated staff was requesting approval and adoption of Permanent Rule 6.UO, "Special" Cash Bingo, Game No. 390; Rule 6.UP, Mega Slots, Game No. 391; Rule 6.UQ, Colorado Millionaire, Game No. 392, Rule 6.UR, Deuces Wild, Game No. 393;

Rule 6.US, Funky 5s, Game No. 394; Rule 6.UT, Lucky Numbers, Game No. 395. Vice-Chair Reeve inquired if there were any comments from the Commission. There were none. Vice-Chair Reeve inquired if there were any comments from the public. There were none. Commissioner Wise made a motion to approve and adopt Rule 6.UO, "Special" Cash Bingo, Game No. 390; Rule 6.UP, Mega Slots, Game No. 391; Rule 6.UQ, Colorado Millionaire, Game No. 392, Rule 6.UR, Deuces Wild, Game No. 393; Rule 6.US, Funky 5s, Game No. 394; Rule 6.UT, Lucky Numbers, Game No. 395. The motion was seconded by Commissioner Martinez and passed unanimously.

Vice-Chair Reeve called for the next item, Public Comment. Pablo Mora, Pueblo Chieftain, inquired if this is the first time the Colorado Lottery offered a \$20 scratch ticket. Vice-Chair Reeve stated that it is the first time a \$20 scratch ticket has been offered.

Vice-Chair Reeve then closed the Public Hearing at 9:13 a.m. and moved into the Regular Meeting.
